## **BEEMAC LOGISTICS, INC CARRIER QUALIFICATION GUIDELINES**

- 1. PROVIDE YOUR MC# AND OR YOUR DOT# TO BEGIN REGISTRATION.
- 2. ALL CARRIERS MUST HAVE AN ACTIVE US DOT NUMBER AT ALL TIMES TO QUALIFY.
- 3. CARRIER CONTACT MUST BE AUTHORIZED TO ENTER INTO AND BIND YOUR COMPANY TO BEEMAC LOGISTICS TRANSPORTATION AGREEMENT.
- 4. PROVIDE THE CARRIER CONTACT INFORMATION.
- 5. SUBMIT AN ELECTRONIC W-8/W-9, OPERATING AUTHORITY AND CURRENT INSURANCE CERTIFICATION, NAMING BEEMAC AS THE CERTIFICATE HOLDER.
- 6. PROSPECTIVE CARRIERS MUST AGREE AND SIGN THE CARRIER CONTRACT WITHOUT ANY ALTERATIONS TO THE CONTRACT. ANY CROSSED-OUT SECTIONS OF THE CONTRACT SUBMITTED WILL NOT BE APPROVED.
- 7. INSURANCE REQUIREMENTS ARE AS FOLLOWS.
  - A. \$1,000,000 MINIMUM AUTO LIABILLITY/GENERAL LIABILITY COVERAGE.
  - B. \$100,000 MINIMUM CARGO COVERAGE. IF THE LOAD IS VALUED MORE THAN \$100,000 THEN THE CARRIER MUST SUPPLY A RYDER POLICY EQUAL TO OR GREATER THAN THE VALUE OF THE CARGO.

## BEEMAC LOGISTICS, INC CARRIER COMPLANCE REQUIREMENTS;

- CARRIER SHALL AT ALL TIMES MAINTAIN A "SATISFACTORY" OR A "NONE" SAFETY RATING AS
  DETERMNED BY THE FEDERAL MOTOR CARRIER SAFETY ADMINISTRATION (FMCSA), U.S.
  DEPARTMENT OF TRANSPORTATON.
- A "CONDITIONAL RATING" WILL NOT BE APPROVED. "CONDITIONAL" CARRIERS WILL ONLY BE REINSTATED ONCE THEIR COMPLIANCE AUDIT HAS BEEN COMPLETED AND THEIR RATING HAS BEEN CHANGED BY THE DEPT OF TRANSPORTATION.
- 3. CARRIER MUST HAVE AN ACTIVE MC/DOT NUMBER FOR AT LEAST 1 MONTH OR MORE. CARRIERS THAT HAVE NOT HAD AN ACTIVE MC/DOT NUMBER FOR A MINIMUM OF 1 MONTH WILL NOT BE ELIGIBLE. THE MC AUTHORITY DATE TAKES PRECEDENCE IN DETERMINING ELIGIBILITY AND REACTIVATION DUE TO MC AUTHORITY BEING REVOKED.
- 4. IF A DOT ONLY CARRIER IS ALREADY ACTIVE IN OUR SYSTEM AND THEN AQUIRES AN MC NUMBER, SAID CARRIER IS GRANDFATHERED, AND WILL REMAIN ELIGIBLE FOR ALL LOADS.
- 5. ALL CARRIER MUST HAVE APPROPRIATE FEDERAL, STATE, OR PROVINCIAL AUTHORITY.
- 6. INSPECTIONS MAY ALSO DISQUALIFY A CARRIERS ELIGIBILITY.
- 7. EXCEPTIONS TO THESE GUIDLINES CAN BE MADE IN THE EVENT OF AN EMERGENCY OR UNFORSEEN CURCUMSTANCE. CARRIER MANAGEMENT AND/OR THE EXECUTIVE TEAM ARE THE ONLY ONES PERMITTED TO OVERRIDE THESE GUIDELINES.
